# **Conservation Funding Available for Irrigation Improvements**

The LRNRD is pleased to announce that agricultural producers have the opportunity to receive conservation funding. In 2016, the USDA Natural Resources Conservation Service (NRCS) awarded the Upper, Middle and Lower Republican NRDs \$2.1 million as part of the Regional Conservation Partnership Program and approximately \$300,000 remain for funding in 2019. Eligible producers have until November 16, 2018 to apply for funding.

Producers in the Upper, Middle and Lower Republican NRDs in southwest Nebraska, which includes all or portions of Perkins, Chase, Dundy, Lincoln, Hayes, Hitchcock, Frontier, Red Willow, Furnas, Harlan, Franklin, Webster, and Nuckolls counties, may apply for funding to make irrigation system efficiency improvements. Eligible conservation practices include: converting gravity systems to subsurface drip with a maximum payment of \$1,000 per acre; permanently retiring end guns on pivots for \$2,000 per acre; and installing high intensity soil moisture sensors for an approximate total of \$5,000 over a three-year period. Priority is given to high water use areas, but all areas within the three NRDs are eligible.

Funding through the Regional Conservation Partnership Program is also available to producers in the Republican NRDs to improve wildlife and pollinator habitat and improve soil health through increasing cover crop and crop rotation activities.

Producers in the Republic Basin NRDs interested in participating in these conservation efforts should contact their local NRCS office and apply for funding by **November 16, 2018**.

## Range Judging & Land Judging Contests

The Area 3 Range Judging contest, one of six statewide, was held on September 18<sup>th</sup> near Elwood. Eleven schools, from Chase County to Red Cloud, participated bringing over 50 teams. The district schools involved were Arapahoe, Red Cloud, and Southern Valley. A total of 189 students and 6 adults competed this year. The participants identified 24 individual plants and evaluated three ecological sites and one ranch map.

Five Senior Division teams from the LRNRD made the top ten with one of the Southern Valley teams placing second overall. The LRNRD also had three Junior Division teams placing in the top ten. The LRNRD hosted the Southwest Region Land Judging Competition on October 3th near Franklin. The contestants evaluated soil thickness, texture, and particle size. They looked at the slope of the land and determined erosion and flood potential. Land judging is a great introduction to understanding the balance between the soil, water, and air, and how that sustains the life of plants and animals.





208 students and six adults competed. 56 teams from 15 schools across the region. District Schools who competed include Alma, Cambridge, Franklin, Southern Valley and Wilcox-Hildreth. Seven district teams placed in the top ten with a team from Alma earning first place and a Franklin team placing second. Congratulations to all the students competing. # **Spring Tree Planting**

It is time to make plans for planting trees next spring. The LRNRD cost-shares trees and shrubs and their planting with minimum orders of 100 trees or \$100.

The benefits of windbreaks are numerous. They protect your home and livestock, and when planted along cropland edges they increase crop production.

Early planning and tree ordering are encouraged. Orders are now being accepted at your county Natural Resources Conservation Service for spring plantings. They will assist you with deciding which tree species will work best for you, draft planting plans, and filling out the cost-share forms. Check with your local NRCS office now. **The deadline for ordering trees is March 8th.** 

# **NSWCP Funding Available**

There is still funding available for the Nebraska Soil and Water Conservation Program (NSWCP). Contact your local NRCS office to apply for cost share. Applications will be approved in order of priority: 1. Water; 2. Range; 3. Erosion.

#### **#KEEPTHESTUBBLE**

Mirrored after the national cancer awareness "No Shave November" campaign, "No Till November" encourages producers keep a different kind of stubble. This fall park the tillage equipment in the shed and leave crop stubble in the field.

There are many benefits to this practice. It improves soil health and allows for more biological activity to continue in the soil. It saves time and money while preserving moisture and reducing erosion.

## 2018 Allocation Usage

The LRNRD board set a 13" cap on water usage for 2018. There will be a **3 to 1 penalty** for usage that exceeds the 13" cap. These caps were set to control the amount of water used this year in an effort to stay in compliance with the Republican River Compact. Water used this year will be deducted from the inches remaining for the 2018-2022 allocation period. The new period began with a total of 45" divide over the 5 years, with up to a 9" carry over.



### **Flow Meter Readings**

The LRNRD technicians are currently reading irrigation flow meters in the District. These meter readings will be used to determine water usage from the 2018 irrigation season. If you are not done irrigating or there is a possibility that you irrigated after your meter was read, please contact our office at 308-928-2182.

Please remember that it is the water user's responsibility to have operational flow meters on every well. The LRNRD provides assistance to water users to make sure that flow meters are reading properly. The LRNRD staff is certified and trained by McCrometer to make necessary repairs. Additionally, we can provide ultrasonic testing to assist water users with their water management decisions. Contact our office if you believe your meter is not working properly. Please have your flowmeter serial number handy when you call.
