Mike Clements had nothing further to add to his written report. Mike did have some correspondence he passed around. Also, Mike presented pictures he had taken of the deep disking project taken down by the Franklin bridge.

Bryan Lubeck asked if there were any questions on his report. Bryan said the biggest positive he has seen is that when you compare the Fall Static Water Levels to last years Fall Water Measurement over all we are a ¼ foot higher. Comparing this Fall to this Spring we are down less than a foot. That is very positive and those figures are over the entire district.

Cammie Kerner, gave the NRCS report. A copy of this report is in the minute book.

Karen Labenz, Dana Cole reported on the FY2010 Financial Statement.

Comments from the public were received by Dan Corman, on behalf of the Nuckolls County Board of Supervisors. The concern was on the property tax that was collected and ruled unconstitutional. Dan encouraged the board to consider returning or credit the tax back.

Dan Smith, Manager, Middle Republican NRD, spoke to the board and encouraged the LRNRD to come back and be a member of the Coalition again. We have too many common needs, common goals, common projects that we need to get back working together on. Dan proposed that the NRD's get together in the next few months, possible starting off with the Executives. Dan is in hopes of getting together as a complete basin now that the TBNRD is a part of the coalition.

Brad Wulf gave the Sustainability Task Force report. The last meeting was here in Alma. The facilitator was there and introductions were made, so everyone is in hopes that more will be accomplished at the next meeting.

Nelson Trambly suggested that agenda item #11 Amendment to Existing IMP be tabled at this time.

Mike Clements said that Pat Underwood has not submitted any grants.

Mike talked to the board about what direction the Board wants the staff to go with measuring Static Water Level measurements. After lengthy discussion it was suggested that the staff continue measuring Static Water wells, but possibly wait until wells have been shut off before taking measurements.

There were no updates on the Rural Water. It was stated that the Rural Water Project is at two-thirds capacity.
