Pat Underwood provided a summary and update of grant activities. We are still waiting to hear back on several Environmental Trust applications and have submitted an application to another private foundation for incentives for beginning farmers to transition to dryland cropping. This is paired with a federal Beginning Farmer Program grant application which is finished and will be submitted before December 22.

The next application Pat proposed is a Conservation Innovation Grant to create a new way to use conservation easements that will work better for our area than the Farm and Ranchland Protection Program and also will cost substantially less than programs like AWEP. Also the BOR WaterSmart grant announcement is expected soon and we will have only a 45 day application window, so if the Board wants to try that again for cleanout of tributaries Pat expects work on that application would start as soon as CIG is submitted.

Pat is also working on setting up another round of soil moisture seminars for this year's CCPI grant.
