Mike briefly talked about the Corps releasing water from Harlan Co. Dam. Mike presented pictures of the river showing the amount of water running due to the water releases. March 18th DNR is having a meeting with the NRD¢s, the Irrigation Districts, and the Bureau of Reclamation in Cambridge.

Bryan Lubeck provided the board with a graph of NRD Tree Sales since 1978 when the LRNRD first started selling trees. Since 1978 the District has planted just over 1.27 million trees. This is an average of nearly 41,000 trees per year.

Nick Simonson gave the NRCS report. A copy of this report is in the minute book. Nick asked the board to approve the field office secretaries signing off on the Conservation of Operation Plans.

On April 17th there will be a Household Hazardous Waste pick up in Alma, Franklin, and Red Cloud. Womenøs Wilderness Weekend will be the first weekend in August.

John Laux, NE Game and Park gave an update on his rental agreement with the NRD.

Kristi Coe discussed with the board the need for a deadline date on the 2009 Supplemental Well Option.

If no pump is present at the inactive well, then no meter is required to be installed.
