Comments from the public: Dale Helm questioned the board on tax valuations.

Nate Jenkins, Upper and Republican Basin Coalition, had questions for the LRNRD board. Nate asked, "What components in the IMP are used to achieve compact compliance, like the allocation reduction, sequencing for pumping curtailment, and a possible shut down option? Can someone describe the analysis that was done that shows that this is going to ensure compact compliance in dry years?" Mike Clements said it would be the same analysis the state provided the URNRD for their plan. Mike asked what the State's analysis was for the URNRD. Nate replied that they are to work cooperatively with the NRDs, looking at the modeling to determine what exactly worked. The URNRD is curious what sort of analysis was done to show that the options that the LRNRD picked independently would achieve the same results? Mike Clements replied that the LRNRD is looking at a number of different things that we are going to do. "It is not just lowering the allocation, it's leasing surface water, permanently retiring acres, temporarily retiring acres. There is a number of different things that play into this. Overall, we are going to factor in the things done in the past and future with the surface water leases, AWEP retirement, then see where we land at the end of a year as far as the department's projections. Then the board will make a determination as to what further measures we may need to take." Nate apologized then asked, "In the IMP process, part of this is statutorily, working together with the State, and where is the State at right now in analyzing your plan? Have you received any input from the State?" Mike Clements responded that the State has reviewed it and we have another meeting scheduled with them February 2<sup>nd</sup>.

Ray Winz asked if the LRNRD proposed an allocation and allocated it over three to five years, if there is any way the board could make that a rolling average.

Mike Clements gave the NARD update. Mike received and read through the legislative bills that pertain to NRD's. A copy of this report is in the minute book.

Pat Underwood gave the grant update. She is currently working on two grants. One is the Conservation Innovation Grant. This grant is using conservation easements as another tool of retirement of acres.

Pat is also working on the BOR WaterSmart Grant.
