Chairperson Nelson Trambly called the meeting of the Lower Republican NRD Board of Directors to order at 2:25 p.m.

<u>Motion #1 by Brad Wulf seconded by Jim Moore to approve the variance minutes and board minutes from the February Board Meetings. Motion carried.</u> Ayes 10 - Clark Andrews, Dave Bartels, Bill Bose, Matt Harrison, Terry Hoit, Marlin Murdoch, Jim Moore, Toby tenBensel, Nelson Trambly, Brad Wulf. Nays 0. Absent – 1 Roger Nelson.

Motion #2 by Matt Harrison seconded by Clark Andrews to approve the February Treasurer's Report as distributed. Motion carried. Ayes 10 - Dave Bartels, Bill Bose, Matt Harrison, Terry Hoit, Marlin Murdoch, Jim Moore, Toby tenBensel, Nelson Trambly, Brad Wulf, Clark Andrews. Nays 0. Absent – 1 Roger Nelson.

Mike Clements entertained any questions on his written report. He added that he had six town hall meetings in the district updating producers on the changes to the GW Rules and Regs and the electronic flow meter changes. Mike said that the NRD was approved for the Environmental Trust Grant at \$130,000 for each of the next two years. The grant cycle will start in July, 2013. The program will be rolled out in 2014 & 2015.

Bryan Lubeck explained that the technicians have gotten several requests for ultrasonic flow meter testing. He feels that this came about because of the overuse of allocations. Bryan explained with only one ultrasonic flow meter it is difficult to get all these requests completed and how it would be beneficial for the NRD to purchase an addition ultrasonic flow meter this next fiscal year. Also, Bryan indicated that the NRD can check the meters, but if the producers wants the meter more accurate they will need to take it to the manufacture to have it calibrated. Questionable meters have been shipped to Aurora to be tested.

Jerry Kovarik, gave the NRCS report. Jerry reported on EQIP and AWEP. Jerry also said that the NRCS has an ultrasonic flow meter the NRD can borrow until an addition one is purchased.

Justin Haahr, NE Game and Parks reported on the Crop Stubble Management, Wildlife & Water Conservation Grant. They applied for an Environmental Trust Grant this year and preliminary approved for \$500,000 a year for three years. This will be split between eight NRD's. Offering up to \$10 for producers to leave either wheat or milo stubble at 14" or taller till April 1st of the following year. The LRNRD was approved for 3,550 acres, if exceeded they will use a ranking system to determine who gets in. Applications will be taken until June 1st. There is a maximum of 320 acres per crop type per landowner. Two workshops will be held in the LRNRD.

Motion #3 by Jim Moore seconded by Dave Bartels to approve partnering with the NE Game and Parks Crop Stubble Management Grant. Motion carried. Matt Harrison talked about the testimony on the  $10\frac{1}{2}$ " cap and how others indicated they would use up right up to the  $10\frac{1}{2}$ ". Matt explained that with that mind set and if we have another dry year like 2012, what will happen in 2014, etc? The majority of the wells not rapid response wells will be off. There will be a 1,666 acre feet for every 2" of reduction for everyone the first year. Matt explained we need to be as prudent as we can.

Bill Bose said till we get a better fix on this problem, he feels he would be more supportive of the thought process if we had more black ink into it. The guys that have managed their water, and carried water over should have the opportunity. If you are a rapid response irrigator and it is as dry in 2013 as in 2012 the rapid response guys are going to be happy with about  $5\frac{1}{2}$ " of water.

Mike Clements said that anticipated projected short fall for 2013 is around 5,500 acre feet. Worst case scenario that 2014 is a continued drought is 5,500 acre feet. That is 11,000 acre feet plus 1,700 acre feet borrowed from the MRNRD that we are going to have to come up with. We can shut off every well in the rapid response are 47,000 acres and in the first year we gain about 8,700 acre feet. Mike agreed with Matt Harrison that this goes beyond the wells in the rapid response. If we are looking strictly at regulations, and we have a shortfall of 12,000 acre feet the rapid response area is going to grow.

Bill Bose and Clark Andrews commented on whether the 10½" cap is going to be enough when they pumped 11" on the effective acres last year. Clark Andrews added on the comments on the people rapid response area feel that everyone should be treated the same. A large majority of the people feel that all wells should be shut off if you are going to shut off the rapid response wells. Mike Clements added that DNR is doing a model run that will tell us exactly what we will get with a complete shutdown. In year one the savings will not be very much.

Motion #4 by Bill Bose seconded by Jim Moore to approve the resolution adopting a one-year pumping limitation of 10.5 inches per acre for the 2013 irrigation season and to charge any irrigator pumping over 10.5 inches, three (3) times any amount pumped over the 10.5 inches, which will be deducted from such irrigation remaining allocation for the 2013-2017 allocation period. Non-mechanical flow meters shall not be allowed on any well after May 14<sup>th</sup>, 2013. Motion carried.
